a Discussion with Eugene Piccolo/Minnesota Association of Charter Schools: Public Policy/Cruz Guzman Case/What is adequate education in the state of minnesota?/The Federal Reserve and Former Judge Page would like to amend the constitution. MDE has established a finance work group to have recommendations for the governor. P20 Council preschool to age 20. A council that includes early childhood to colleges and k-12. The state goal is that 70% of all adults are prepared for the workforce. It all works back from there.

Charter School Law was amended in 2009. This is the last time any big changes have been made.
